## **Professor (W3) of Orthodontics (Successor to Univ.-Prof. Dr. med. dent. Stefan Kopp)**

You exhibit scientific excellence and will represent the field of orthodontics in research and teaching and, as Director of the Department of Orthodontics at the Center for Dentistry and Oral Medicine that is run by Carolinum Zahnärztliches Universitäts-Institut gGmbH, you will be entrusted with the ambulant dental management of patients related to research and teaching.

We are looking for a candidate with comprehensive clinical expertise in the field of orthodontics, experience in leading a clinical institution and excellent scientific qualification (habilitation or proof of equivalent scientific achievements) demonstrated by, among other things, high-ranking international publications and competitive acquisition of third-party funding. Further, didactic competency and documented successful teaching are expected. In particular, you shall give impulses for innovative and integrated teaching under consideration of the national competency-based learning outcome catalogue (NKLZ) and the new approval regulations in dental medicine (ZApprO) that are under implementation. You will actively collaborate in the existing postgradual Master's programs Oral Implantology, Dental Esthetics und Dental Technology.

We expect special organizational skills, ability to cooperate and work in a team, willingness to interdisciplinary cooperation in patient care, research and teaching with the neighboring disciplines of the Center of Dentistry and Oral Medicine (Carolinum), i.e., cariology, endodontology and pediatric dentistry, oral surgery and implantology, periodontology as well as prosthodontics. Regarding the care for patients with orofacial malformations you will narrowly collaborate with the Clinic for Oral, Cranio-Maxillofacial and Facial Plastic Surgery at the University Hospital Frankfurt.

The formal hiring requirements are defined in sections 67, and 68 of the Hessian Higher Education Act (Hessisches Hochschulgesetz).
